# Questions for Northwest Ohio Corrections, Ohio RFP #2023-003: Inmate Health Care & Mental Health Services

### Question #1 - Attachment A

Attachment A shows cap expenses from 2021 through May 2023. Can you please specify what each cap represents in relation to the services rendered to each cap (example: how much of each cap is for pharmacy expenses)?

a. The current contract provides a cap for pharmaceutical and the other cap includes x-rays, labs, hospital and specialized visits, TB tests, etc. As you can see after the cap has been expended, CCNO covers the costs.

# Question #2 - Rx/month

What is the average number of prescriptions filled per month for the past 12 months?

a. Answer provided by current vendor; SHP - Average 1,000 RX per month

# Question #3 - Packaging

What type of medication packaging (blister cards, vials, strips, other) do you currently use, and do you wish to keep the same packaging system?

a. Blister cards

# **Question #4 - Quantities**

How many days' worth of medication (7, 14, 30 days) is typically dispensed for routine medication orders and do you wish to keep it the same?

a. Answer provided by current vendor; SHP – 30 days. CCNO will take the recommendation of the provider.

# **Question #5 - 340B**

Who is the 340B covered entity that your current medical or pharmacy vendor has negotiated with on behalf of CCNO to obtain cost savings on HIV and other costly medications?

a. ODRC has a reimbursement plan as well as Ryan White Foundation.

#### Question #6 - Inspections

How often does your current pharmacy vendor provide, or coordinate, inspections of the medication areas at your facility?

a. Answer provided by current vendor; SHP – Quarterly

#### Question #7 - Utilization Data

Knowledge of medication utilization data is extremely important for medical bidders in determining a final and accurate bid rate in response to your solicitation. Not providing this actual medication utilization data to all bidders will result in a competitive advantage to your incumbent medical vendor who already has this information and knows those costs.

Because public money is used to pay for pharmacy services and medications under the current contract, our understanding is that medication utilization and cost information would not be considered proprietary and can be readily separated by your current medical vendor or their subcontracted pharmacy.

- Can CCNO please request a two-month report for April 2023 and May 2023 with actual pharmacy dispensing data detailed by line item reflecting the fill date, medication name and strength, quantity dispensed, and medication price (with patient names redacted) as an addendum to the RFP?
- a. Answer provided by current vendor; SHP Attached are utilization reports only, as pricing under the current vendor is confidential.

#### **Ouestion #8 - Electronic Reconciliation**

Many correctional institutions within the industry are using electronic check-in and return programs for inventory management. Manual daily order check-in and return processing time can be decreased by up to 75%, medication diversion potential is virtually eliminated, and CCNO will have full accountability of all medications received by, and returned from, your facility for accounting purposes.

- What is the name of your current barcode electronic order reconciliation (check-in) and medication return management system that is provided by your current medical vendor?
- Would you find value in adding this requirement to your current solicitation for bidders to provide a free solution for electronic inventory management if a solution in not currently in place?
- a. The current provider does not use an electronic barcode. It will not be a requirement but it can be part of the proposal if the bidders choose to.
  - Answer provided by current vendor; SHP These functions are completed through the current pharmacy vendor's proprietary online customer portal.

#### Question #9 - Online Reporting Access

Many correctional institutions within the industry have fingertip access to meaningful and actionable electronic reporting. Analyzing prescriber ordering trends and expenditures to better manage facility operations is critical to your administrative team and dependent upon reliable and accurate reporting.

- What is the name of the current online reporting dashboard used by facility and county administrative staff to access meaningful and accurate reporting?
- Would you find value in adding this requirement to your current solicitation for bidders to provide a no cost solution for online reporting so your facility-level staff and administrators can access online reports 24/7/365 if a solution is not currently in place?
- a. It will not be a requirement but it can be part of the proposal if the bidders choose to.

#### Question #10

Does CCNO have a board of pharmacy issued Terminal Distributor of Dangerous Drugs (TDDD) permit that allows for stock medications to be kept on site for first dose and emergency needs?

- If so, what is the Class and Category of the TDDD permit?
- a. Answer provided by current vendor; SHP Terminal Clinic License Category 3, expires 2025.

# Question #11 - Current Pharmacy Pricing Structure

Regarding the cost pool for pharmaceuticals before those expenses become the responsibility of CCNO?

- Once the cap is reached, are medications billed to CCNO at cost plus a dispensing fee for the remainder of that contract year?
  - o if so, what is the dispensing fee?
  - o If not, what is the pricing formula the medical vendor is using to bill CCNO for these medications and how are those costs audited by CCNO?
- Regarding credit on unused medications, once the cost pool is exceeded for pharmaceuticals
  and all medication costs are those of CCNO, does the current medical vendor or pharmacy also
  provide credits on returned medications directly back to CCNO?
- a. Answer provided by current vendor; SHP No additional dispensing fee. The pricing formula is proprietary to the current vendor. Yes, credits are issued on returned medications back to CCNO.

# Question #12 - Independent Pharmacy Benefits for CCNO

On RFP Page 4 it states, "Bidders may, but do not need to, submit alternate proposals. If a bidder submits alternate proposals, the Corrections Commission may, at its option, select any of the proposals based on the determination as to which proposal is most favorable."

RFP Page 11, Section 3.02 states, "The Corrections Commission reserves the right to reject any and all proposals at any time, either before or after the opening of proposals, or to award the contract in whole or in part."

Independently contracting your pharmacy services has potential benefits over incorporating pharmacy into a comprehensive health services model. As an individual discipline, a pharmacy will provide a checks and balance system that will independently monitor for and directly report to CCNO, any irregular prescriber ordering habits, excessive medication utilization, cost effectiveness of medication selection, and compliance with local, state, and federal laws, rules and regulations.

- Would CCNO permit an informational response to your RFP along with a cost-plus dispensing fee-pricing model from industry-leading vendors that specialize in correctional-based medication dispensing and pharmacy program management?
- a. CCNO is interpreting it that we can allow alternative proposals.
